Refer to the above mentioned subject and Ellaheeb's emails regarding the MS and JHA for Wash Tank at Stations# 6, Amal Field, please be noted that all documents were being found same except documents received in the second email. Ellaheeb had showed the spray system from inside the tank i.e. different angle and therefore this method of statement and the JHA are not satisfactorily for the following reasons:

1. It does describe the job step by step in details, it is rather giving general description.
2. It stated that the required amount of water is about 60 m³/day and they have 2X20 m³ water tanks with two water pumps each with the capacity of 12m³/hr, the question is how will they compensate for the required water.
3. A CV has been submitted for (mechanical engineer) but it is not clear for what position?
4. It is not clear how Ellaheeb will transport disposal to the pit.
5. No clear procedures for opening the tank and installing the spray system.
6. The JHA is not listing the required hazards and controls in details.
7. Ellaheeb referred to a general OSHA guidelines links which many of them did not work, these guidelines tell us what we have to do but they do not tell us how we will do it, this depends on arrangements and systems what we have.

You quick response will be highly appreciated.


